- Data Residency: Currently, Workforce Go's primary platform is in the US POD. If a Canadian business requires their data to reside solely within Canada due to provincial laws or sector-specific regulations (especially for public sector data or health information), we may not be a fit at this time until access to a Canadian POD is gained. While PIPEDA doesn't strictly mandate data localization, it requires comparable protection, which can lead to practical data residency needs.
- Payment: Global Pay (ACH only) is currently the only form of payment accepted. Payment instructions, including routing and bank account numbers, will be provided on the invoice.
- Canadian Compliance: Workforce Go is built to work within the parameters of national and local laws. Our platform is designed to help with compliance with Canadian regulations, including federal and provincial labor laws, employment standards, and privacy regulations like PIPEDA.
