- **Canadian Compliance:** Workforce Go is built to work within the parameters of national and local laws, as well as Union regulations. Our platform is designed to help with compliance with Canadian regulations, including federal and provincial labor laws, employment standards, and privacy regulations like PIPEDA.
- **In Country Data Restrictions:** While Canada does not have a blanket rule requiring all data to reside solely within Canada, provincial laws and sector-specific regulations (especially concerning public sector data or health information) may have stricter requirements. PIPEDA requires comparable protection regardless of storage location, which can lead to practical data residency needs. **If data must reside in Canada, we are not currently a fit** until such time we gain access to a Canadian POD.
- **Global Pay:** Global Pay (ACH only) is currently the only form of payment accepted. Payment instructions, including routing and bank account numbers, will be provided on the invoice.
